

Season of Gigging Official Rules:

This Promotion is sponsored by A3 Mobility LLC, PO Box 24502, Oakland, CA 94623 ("Sponsor" or "Gig"). Each Gig member who takes a trip in a Gig vehicle from 12/5/22 through 12/11/22 ("Entry Period 1") or 12/12/22 through 12/18/22 ("Entry Period 2") and meets the following eligibility requirements will be entered into a drawing from which one (1) winner will be randomly selected from all entries received during the same Entry Period to receive a \$100 credit to his or her Gig account ("Gig credits" or "credits").
